**The statement by the
Congress of European Azerbaijanis
addressed to the European Parliament against the biased resolution adopted about
Azerbaijan Republic**

Azerbaijan has been always cooperated and continues to successfully cooperate with international organizations, supporting the discussions and decision-making process of the issues that are in line with its national interests and mutual interests with Europe.

But under the influence of outside parties, some organizations have been displaying a non-objective and biased attitude towards Azerbaijan. Such biased attitude has been chronically displaced in the European Parliament. It is proved by the fact that some pro-Armenian groups in the European Parliament and Council of Europe are constantly attacking Azerbaijan.

The adoption of the resolution, regarding blogger Mehman Huseynov on 17.01.2019 is one more example of the double standards of the European Parliament's and it is a manifestation of biased attitude towards Azerbaijan.

For some reason, the issue of Mehman Huseynov is intentionally inflamed by the influential international organization such as the European Parliament, which is blind to the crimes, terrorism and illegality committed in Armenia, at the parliamentary level, or does not see the recent gross violations of human rights against people in European countries, including France, and EP does not hold any discussions, and no any decisions are made.

The EP's not applying to the Parliament of the Republic of Azerbaijan, the Ministry of Foreign Affairs of the Republic of Azerbaijan or the Azerbaijani Embassy in Brussels and not inviting on the urgent hearings in the European Parliament any representative from Azerbaijan exposes the lies of Rebecca Harms who claimed that she was trying to establish contacts with his Azerbaijani counterparts.

The next case proving the hypocrisy of the members of the European Parliament none of the members of the European Parliament, who spoke at the debates about Human Rights in Azerbaijan, did not even remember about more than a million Azerbaijani refugees and internally displaced persons whose fundamental human rights have been violated for many years.

The Congress European Azerbaijanis consider the prejudiced resolution adopted by the European Parliament reflecting disrespect to the principles of international law and the biased accusations against Azerbaijan which are reflected regular basis and is an integral part of the campaigns carried out against our country. The Congress declares that behind these campaigns, are standing certain groups that are under the influence of the Armenian lobby and anti-Azerbaijani forces that are jealous of the development of our country.

The sole purpose of these groups is to undermine Azerbaijan, which is developing a modern, independent policy, to formulate wrong ideas and to mislead about Azerbaijan in Europe.

The Congress European Azerbaijanis strongly condemns the European Parliament's biased resolution against Azerbaijan and strongly demands the end of the double standards policy against Azerbaijan.
